- Article I. These Guidelines are enacted to encourage students to achieve outstanding performance; qualified scholars can be good examples for other students.
- Article II. There are Outstanding Performance Scholarship, Academic Distinction Scholarship, admission scholarships, and tiptop scholarships offered by different programs to encourage better academic performance among students and help them reduce their financial burden; the grants process is described as follows:

1. Outstanding Performance Scholarship:

- 4-year College and 2-year College students or 5-year Junior College students whose academic overall scores and conduct scores are 90 points or higher in each semester.
- (2). Grants (prizes) and certificates of award will be awarded to the scholars.

2. Academic Distinction Scholarship:

 4-year College and 2-year College students or 5-year Junior College students whose academic overall average scores are 85 points or higher and their conduct scores are 82 points or higher in each semester.

- (2). Based on the academic scores, two students with the highest scores will be selected as the scholars in each class, in each semester; however, winners of the utstanding Performance Scholarship are out of this selection. Scholars from the Dept. of English in the 5-year Junior College should have different minor fields of study. Grants (prizes) and certificates of award will be awarded to the scholars.
- 3. Admission scholarships offered by different programs: Adjustments will be made to the Guidelines for the Implementation of Admission Scholarships in an Academic Year based on the actual state of student recruitment. The Guidelines will be formulated in a separate document.
- 4. <u>Various tiptop scholarships: provide scholarships for international learning,</u> <u>cross-field learning, and language learning during the period of their studies. The</u> <u>Guidelines will be formulated in a separate document.</u>
- Article III. Approved scholarships or scholarships are as follows
 - 1. If the applicants have the same academic scores, the scholarship will be granted for the one whose conduct scores are higher; if their conduct scores are the same, two of them will become scholarship recipients.
 - 2. To receive an Academic Distinction Scholarship or Outstanding Performance Scholarship, a student shall take the requisite credits that meet the minimum requirements set by the Academic Policies every semester. Also, he/she should not withdraw from a course, and should take at least 3 courses (including an external internship).
 - 3. <u>If conforming to the two criteria at the same time, Outstanding Performance</u> <u>Scholarship and Academic Distinction Scholarship will not be awarded repeatedly.</u> The evaluation of eligibility for an Academic Distinction Scholarship or Outstanding Performance Scholarship will be carried out by the Office of Academic Affairs according to this Article <u>after the 1st Academic Affairs Committee meeting of each</u> <u>semester.</u> A tabulation of scores will be submitted to the President for ratification.
 - 4. Those who wish to continue to receive a scholarship in the next semester should take the requisite credits that meet the minimum requirements set by the Guidelines for Course Selection, and should not withdraw from a course.
- Article IV. Depending on changes in the amounts allocated and admissions via multiple channels every academic year, appropriate adjustments may be made to the allocation and amounts of scholarships listed in the Guidelines.
- Article V. These Guidelines become effective after approval by the Executive Committee and ratification by the University President. Amendments must follow the same procedure.
